

WORKOUT AGREEMENT

THIS AGREEMENT is executed between _____ (the "Player") and Kansas City Royals Baseball Corporation (the "Royals"):

1. The Player acknowledges that his birth date is _____, that his social security number is _____, that he is a baseball player, and that he is desirous of playing professional baseball for a professional baseball team. The Player is participating in a workout and/or tryout at _____ (Facility) in _____ on _____ (Location) (Date)

2. In consideration of the Royals permitting Player to appear in a workout/tryout, the Player agrees as follows:

(a) The Player is not an "employee" of the Royals within the meaning of the Worker's Compensation statute of law in the jurisdiction where the workout(s) and physical conditioning takes place and during the period of the workout(s) and physical conditioning.

(b) The Player acknowledges that he is duly aware of, and knowingly and voluntarily assumes the risks of physical injury and hazards, including death, inherent in appearing and performing at workouts or tryouts. The Player agrees and covenants not to sue the Royals, its parents, subsidiaries, affiliates, agents, officers, servants, employees, assigns or stockholders in law or in equity and shall waive all claims (including Worker's Compensation) and not cause a lawsuit to be brought for or on account of any and all claims, demands, rights, and cause or causes of action, whether known or unknown, of whatsoever kind and nature (including any negligent act or omission on the part of the Royals, its parents, subsidiaries, affiliates, agents, officers, servants, employees, assigns or stockholders) arising from, or by reason of any and all bodily and personal injuries incurred by him in his appearance or performance hereunder, and the consequences thereof. **THIS AGREEMENT EXPRESSLY WAIVES AND RELINQUISHES ANY CLAIM FOR WORKER'S COMPENSATION OR NEGLIGENCE AGAINST THE ROYALS WHICH ALLEGEDLY ARISES FROM PLAYER'S APPEARANCE AND PERFORMANCE AT WORKOUTS AND TRYOUTS.** The Player agrees that this Agreement shall bind the Player and his spouse, heirs, next of kin, personal representative(s), executors, and administrators.

(c) The Player agrees that this Workout Agreement may be terminated by the Royals without notice or reason at any time, that the Player will not receive any pay during the workout(s) period, and that the Player will not receive any compensation, benefits, expenses, or remuneration of any form or nature whatsoever, and that participation in the workout(s) is voluntary and solely at the Player's expense.

(d) This Workout Agreement is valid only on _____.

3. The Player acknowledges voluntary execution of this Agreement and acknowledges that he has read and fully understands the same. If the Player's native language is other than English, the Player acknowledges that he understands this Agreement as translated to him in his native language.
